## **GENERAL DESCRIPTION**

The individual in this title would ensure that patients eligible for or in need of special accomodations for the intellectually disabled would have access to these services. They will make sure that the facility is in compliance with delivery of educational services to all patients and is maintaining adequate functional programming for those who require or request it. This includes assuring that the curriculum and program content are delivered within the required guidelines of the State of NJ Dept. of Education. They will be responsible for Individual Education Plans and/or the education portion of Individual Habilitation Plans for each pupil under their assignment and implement educational programming as prescribed for each pupil. They will coordinate recommendations of the Speech Therapist, Physical Therapist, and other professional members of the inter-disciplinary committee. They will also collaborate with patient treatment teams from the education perspective.

TEACHER 1: EDUCATION: Possession of a valid Standard Certificate issued by the State Board of Examiners of the New Jersey Department of Education with an endorsement in subject area(s) determined appropriate by the Appointing Authority.

NOTE: In departments/agencies in which the position functions as a short-term substitute for a Teacher, 3 or 2, or as determined appropriate by the Appointing Authority, a current valid New Jersey Substitute Teacher's Certificate issued by any county educational office, or a current valid Certificate of Eligibility or Certificate of Eligibility with Advanced Standing in any area, issued by the State Board of Examiners of the New Jersey Department of Education may be substituted for the above certificate.

SPECIAL NOTE: Ability to physically lift, move, and position students.

TEACHER 3: EDUCATION: Possession of a valid NJ Standard Teacher's Certificate or Permanent Endorsement, issued by the Board of Examiners of the New Jersey Department of Education, authorizing instruction in subjects areas appropriate to the teaching assignment, as determined by the head of a particular school or district.

NOTE: Teacher 3 is utilized to teach differing student populations and different content areas; therefore, the specific teaching certificate may vary.

EXPERIENCE: Thirty-six (36) months of full-time, properly certified teaching experience in an approved school, earned after the receipt of the New Jersey Standard Teacher's Certificate.
