### CRITERIA FOR BECOMING A NJ TRANSIT POLICE OFFICER

#### AGE

- Candidates must be at least 21 years of age by date of testing, and **NOT** have reached their 35th birthday at the time of appointment to the Police Academy Training Program ("PTC"); unless covered by the PTC age requirement guideline New Jersey Statute; **N.J.S.A. 43:16A-3**

#### CITIZENSHIP

- Candidates must be citizens of the United States on the date of application submission, and never have renounced United States citizenship.

#### DRIVER'S LICENSE

- Candidates must have a driving record in good standing and valid motor vehicle driver's license on the date of application submission.

**A candidate will be rejected from the selection process that has intentionally misrepresented, falsified, or concealed material and that, upon submission of any official document (online or otherwise), made a false statement, or attempted to practice any deception or fraud in this initial application, examination, interview, background, or in securing eligibility for appointment.**
