## GENERAL DESCRIPTION

The Communicable Disease Service (CDS) is hiring a Research Scientist 2 (AR Coordinator). The position will be responsible for coordinating multi-drug resistant organisms (MDRO) surveillance, response, and containment activities in healthcare facilities throughout New Jersey such as acute care, long-term care, and outpatient facilities. They will assist with the development, preparation, review and distribution of procedures and protocols for MDRO investigations. The AR Coordinator (Research Scientist 2) will analyze data gathered during outbreak investigations using appropriate statistical methods and computer software. They will prepare and distributes reports and feedback to healthcare providers, local health departments and other internal partners in CDS. The AR Coordinator (Research Scientist 2) will be a key contributor for the grant-required MDRO Prevention Plan, using assessment data to help establish a plan for NJDOH. They will provide guidance to CDS, regulatory agencies, local health departments, health care providers, hospitals and others during MDRO outbreaks. Lastly, the AR Coordinator will also partner with the Antimicrobial Stewardship Coordinator to address prevention of antimicrobial resistance throughout various healthcare setting types.

The successful candidate will have the ability to work independently, organize, plan, and manage time effectively to complete assignments. The candidate will have excellent written and verbal communication skills and will have expertise and experience with antimicrobial resistance surveillance data, outbreak investigations, infection control, data analysis, and reporting. The ability to travel on-site to healthcare facilities is preferred. Preference will be given to those candidates who have experience working with the antimicrobial resistance data in healthcare/public health or those with a PharmD.

## REQUIREMENTS (EDUCATION / EXPERIENCE / LICENSES)

**EDUCATION:** Graduation from an accredited college or university with a Master's degree in a discipline appropriate to the position.

**EXPERIENCE:** Three (3) years of full-time experience in a field appropriate to the position.

**NOTE:** A Doctorate in a discipline appropriate to the position may be substituted for two (2) years of experience indicated above.

**LICENSE:** Appointees will be required to possess a valid driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essentials duties of the position.
