DESCRIPTION OF MAJOR DUTIES:

The Finance team manages over \$10B in federal funds. This position would be responsible for accurate tracking and reporting and ensuring eligible use of funds; As a result, this finance position includes but is not limited to such job duties as planning, budgeting, reconciliation, actuals tracking, analyses, interfacing with state, federal and management systems, and reporting. This position also requires the use of technical skills in the analyzation, interpreting and application of programmatic policies, procedures, and regulations/laws governing the financial process; as well as providing counsel and advice to Leadership based on research and results of analyses.

REQUIREMENTS

EDUCATION/EXPERIENCE: NOTE: Applicants must meet one of the following or a combination of both experience and education. Thirty (30) semester hour credits are equal to one (1) year of relevant experience.

Six (6) years of professional experience in the collection, analysis, evaluation and presentation of financial data used to provide an accurate accounting of administrative and operating costs and the preparation of reports containing conclusions and recommendations for a private business or government agency.

OR

Possession of a bachelor's degree from an accredited college or university; and two (2) years of the above-mentioned professional experience.

OR

Possession of a Master's degree from an accredited college or university in Business Administration, Public Administration, Accounting or Finance; and one (1) year of the above-mentioned professional experience.

NOTE: "Professional experience" refers to work that is creative, analytical, evaluative, and interpretive; requires a range and depth of specialized knowledge of the profession's principles, concepts, theories, and practices; and is performed with the authority to act according to one's own judgment and make accurate and informed decisions.

LICENSE: Appointees will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.
