OFFICE DESCRIPTION

The New Jersey Department of Transportation (NJDOT) is seeking applications for candidates for the position of **Senior Engineer, Structural Bridge Design.** Senior Engineers in the Structural Design and Geotechnical Engineering Unit are assigned a 40 - hour work week with the potential for overtime. The standard workweek is Monday through Friday. Work experience within this unit will qualify as approved design experience for the issuance of a New Jersey Professional Engineer (P.E.) License.

The Division of Bridge Engineering and Infrastructure Management plans, organizes, oversees, and implements the various work programs in the offices of Structural Design and Geotechnical Engineering, Structural Evaluation and Bridge Management, and Structural Engineering Services

UNIT DESCRIPTION

The Structural Design and Geotechnical Engineering unit is responsible for performing structural and geotechnical engineering design services for in - house bridge design projects. Structural engineers within the unit's Structural Design squads conduct inspections and field investigations to collect data in support of bridge design projects, design bridges and other structures, and prepare design calculations, contract plans, engineering estimates, and specifications (PS&E Packages). Structural engineers also provide engineering support services during construction, which includes providing responses to Requests for Information (RFIs), working drawing review, and field visits to investigate and resolve unanticipated construction conditions.

POSITION DESCRIPTION

The daily functions of the Structural Design unit include, but are not limited to:

Functions:

- Perform structural designs for in house bridge design projects.
- Design and produce structural contract documents (Plans, Specifications, and Estimates) for in house design projects, including bridges, culverts, retaining walls, sign structures, and other related transportation structures.
- Provide Subject Matter Expert (SME) opinion for developing structural scope of work for various projects.
- Serve on proposal technical evaluation committees to support Project Management in reviewing Expression of Interest (EOI) and Technical Proposals during the consultant selection process.
- Coordinate with SMEs of various disciplines throughout the department for the development of structural engineering designs for in house projects.
- Prepare bridge and structure related engineering estimates and specifications.
- Work closely with the Geotechnical Engineering unit to prepare foundation designs.
- Provide structural construction engineering services consisting of working drawing reviews, technical interpretations, responses to RFI's, field inspections, and resolution of emergent construction conditions for in house design projects.

REQUIREMENTS

Education: Graduation from an accredited college or university with a Bachelor's degree in Civil Engineering.

NOTE: A Bachelor of Science degree in Engineering Technology (BSET) in a field related to civil engineering from an accredited college having a curriculum approved by the Accreditation Board of Engineering Technology (ABET) meets the above education requirement

NOTE: Possession of a valid license as a Professional Engineer issued by the State Board of Professional Engineers and Land Surveyors may be substituted for the Bachelor's degree in Engineering

Experience: Two (2) years of experience in structural design and/or structural engineering work.

Proof of Degree: You must provide transcript or evaluation of your **UNDERGRADUATE** degree. Foreign degree evaluation must be evaluated by a USA recognized evaluation service and include your course - by - course evaluation.

<u>Incomplete Packets:</u> Applicants MAY NOT be considered if they fail to provide all requested documents upon initial submittal or fail to follow instructions when submitting electronically. Applicants will be selected for an interview on the basis of their application/resume.
