<u>DUTIES</u>: Under the direction of a Bureau Chief, Assistant Bureau Chief, Deputy Insurance Fraud Prosecutor, or the Insurance Fraud Prosecutor in the Office of the Insurance Fraud Prosecutor, Division of Criminal Justice, Department of Law and Public Safety, conducts work concerned with the detection and prosecution of private insurance fraud; interprets and enforces laws and regulations; as the Attorney General's representative, participates in legal and related activities involving federal and local jurisdictions and other State entities; drafts memorandums of law; prosecution memorandums; criminal accusations and indictments; handles all aspects of case litigation related to insurance fraud prosecution, including but not limited to case assessment, research, discovery coordination, grand jury presentations, court appearances, pre-trial preparation, trial practice, court filings (motions, briefs, sentencing documents), attorney correspondence and case management; particular focus on investigating and prosecuting fraud involving health, automobile; homeowners, workers compensation, annuities and other private insurance; works closely with law enforcement in the development of case investigations and prosecutions; performs other related work as required.

## **REQUIREMENTS**

**EDUCATION:** Graduation from an accredited law school with a Juris Doctor. Admission to practice as an Attorney at Law in the State of New Jersey is required.

## EXPERIENCE:

DEPUTY ATTORNEY GENERAL 4: Two (2) years of experience as a practicing attorney. DEPUTY ATTORNEY GENERAL 3: Three (3) years of experience as a practicing attorney.

**LICENSE**: Appointee will be required to possess a driver's license valid in New Jersey.

\*SALARY NOTE: For newly hired individuals, the starting salary and title will be determined by the Department commensurate with experience. Salary offers are non-negotiable and will fall within the range posted.

**SPECIAL NOTE:** Current Department employees appointed to a Deputy Attorney General 4 or Deputy Attorney General 3 title must be willing to accept a lateral transfer, if selected.

**RESUME NOTE**: Eligibility determinations will be based upon information presented in resume only. Applicants who possess foreign degrees (degrees earned outside of the U.S.) are required to provide an evaluation indicating its U.S. equivalency prior to the closing date.
