Description:

Under general direction of the Director of the Office of Preschool Education, the Governor's Fellow will assist with updating existing guidance documents and developing new documents related to preschool expansion including requirements of school districts, best practices and current research; assist in the review of enrollment trends based on data collection to develop support for universal preschool enrollment being achieved in local education agencies; and performing other related work as required. This is a one year fellowship.

Requirements:

Graduation from an accredited college or university with a Master's degree and a combination of established excellence in academics and/or professional achievement; proven leadership ability and potential for further growth; demonstrated commitment to public service; effective written communication skills as demonstrated by writing assignment; evidence of effective teamwork.

NOTE: Applicants may utilize college credits in combination with the indicated experience to meet the job requirements. These credits will be applied on a year-for-year basis with thirty (30) semester hour credits being equal to one (1) year of experience.

Applicants may also be considered if they have successfully completed military service or long-term public service work with an organization such as AmeriCorps, Teach for America or the Peace Corps. Other service will be considered on a case-by-case basis.

Preferred Education/Experience: Graduation from an accredited college or university with a Master's degree in Education, Early Childhood Education (preschool to grade three), or related field.

Open to the Following:
