Opportunities currently exist in the unclassified service with the Department of Law and Public Safety, Office of Public Integrity and Accountability, for applicants who meet the requirements specified below:

TITLE: Deputy Attorney General 4

SALARY: \$93,816.41 to \$133,882.16

LOCATION: Office of Public Integrity & Accountability Corruption and Integrity Bureaus Trenton, Cherry Hill, **OR** Cedar Knolls, NJ *Statewide travel required for work responsibilities.*

<u>NUMBER OF POSITIONS AVAILABLE:</u> Two (2) – location preference required.

DUTIES: Under the direction of the Bureau Chief, Deputy Bureau Chief, or other supervisory official in the Office of Public Integrity and Accountability, investigates and prosecutes violations of New Jersey criminal laws, specifically related to public corruption offenses and criminal activities that violate the public trust. This Deputy Attorney General will provide legal advice and representation of the State on matters of a complex nature; interpret and enforce laws and regulations; participate in legal and related activities involving federal and local jurisdictions and other State entities; draft memoranda of law; handle all aspects of case litigation, including but not limited to case assessment, legal research, discovery coordination, grand jury presentations, court filings, attorney correspondence, court appearances, motion practice, pre-trial preparation, case management, and trial; serves on various task forces and working groups for the Division or LPS; works on special projects and initiatives; and performs other related work as needed. This position may also require non-traditional work hours, on an as needed basis, including evenings and weekends on short deadlines for certain assignments, with or without advance notice, and may require travel to perform the aforementioned responsibilities.

REQUIREMENTS

EDUCATION: Graduation from an accredited law school with a Juris Doctor. Admission to practice as an Attorney at Law in the State of New Jersey is required.

EXPERIENCE: Two (2) years of experience as a practicing attorney.

LICENSE: Appointee will be required to possess a driver's license valid in New Jersey.

PREFERENCE: Preference will be given to candidates with a demonstrated ability to multi-task and work effectively with a broad cross-section of stakeholders; and excellent written and oral advocacy skills.

Applicants who possess foreign degrees (degrees earned outside of the U.S.) are required to provide a CSC approved evaluation indicating the U.S. equivalency, with a course-by-course breakdown, prior to the closing date (see <u>CSC foreign degree information</u>). Failure to do so may result in disqualification of your education towards eligibility.

All offers of employment are conditional subject to the applicant agreeing to and then passing a background check that may include fingerprinting.
