**DESCRIPTION OF THE SPECIFIC POSITION:** Lead a highly skilled team of Data Center network design, implementation, operations and migration, engineering team. Perform problem resolution solve sophisticated, multi-functional issues that cross many technologies in network, server, storage, O/S, virtualization, DNS, Firewall, Switch, Router, Load Balancers, Monitoring Systems, Middleware, Applications, operations, content switching, caching and/or content delivery networks. Apply good analytic processes to help bring any issue to resolution regardless of domain ownership. Manage projects applicable to the above core duties.

**DEFINITION:** Under direction of a Division Director or Deputy Director, or other higher level administrative official, directs the staff and activities of an operational unit responsible for providing general administrative and varied social services to a specific client population; does other related duties as required.

**REQUIREMENTS:**

**EDUCATION:** Graduation from an accredited college or university with a Bachelor's degree.

**EXPERIENCE:** Six (6) years of experience in a large and complex network administration, three (3) years of which shall have involved project management/oversight responsibilities in the fields of internetworking architecture, wide area network, data center, and backbone engineering and responsibility for budget/fiscal affairs.

**LICENSE:** Appointees will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.

**FOR NON-U.S. CITIZENS AND/OR FOREIGN DEGREES**

**AUTHORIZATION TO WORK:** U.S. Citizenship is not required. Applicants must be authorized to work in the United States according to the Department of Homeland Security, United States Citizenship and Immigration Services regulations. NJOIT does not provide sponsorship or accept student OPT/CPT programs, F1 or H1B work authorization visas.

Foreign degrees must be evaluated by a recognized evaluation service and include your course-by-course evaluation. If you do not live in New Jersey, you have one year after you begin employment to relocate your residence to New Jersey. Employees who fail to meet the residency requirements or obtain an exemption will be removed from employment.
