GENERAL DESCRIPTION

Under the supervision of the Executive Director of the Office of Long-Term Care Resiliency, the Nursing Consultant will participate in the development of quality management policies and conduct periodic quality management reviews. Will evaluate data to manage efficiency and productivity of field operations. Will collaborate with the long-term healthcare team to assure implementation of infection prevention and control practices.

The position will educate healthcare personnel and the public about infectious diseases and how to limit their spread. Will provide consultation and assistance in the resolution of long-term care issues, problems, or complaints. Will also provide consultations to prevent Healthcare-Associated Infections (HAIs) in health care facilities by isolating sources of infections and limiting their transmission.

The Nursing Consultant will be responsible for collecting, analyzing, and interpreting health data in order to track infection trends, plan appropriate interventions, measure quality, and report relevant data to public health agencies.

This position may be eligible to participate in the Department's pilot telework program, which offers eligible employees the opportunity to work remotely for up to two (2) days per week, as approved by management.

REQUIREMENTS (EDUCATION / EXPERIENCE / LICENSES)

EDUCATION: Graduation from an accredited college or university with a Bachelor's degree in Nursing or related health field and a Master's degree with a major course of study in Nursing Supervision, Administration, Public Health, Medical Care, Nursing, Health Education, or related health field.

NOTE: Applicants who do not possess the required Bachelor's degree but possess an Associates degree in Nursing or graduated from an accredited School of Nursing may substitute two (2) years of additional clinical nursing experience as indicated.

NOTE: Applicants who do not possess the required Master's degree may substitute one (1) year of additional clinical nursing experience as indicated.

EXPERIENCE: Six (6) years of clinical nursing experience in an acute care, long-term or community-based setting.

LICENSE: Current registration as a Professional Nurse in the State of New Jersey.

Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform essential duties of the position.
