GENERAL DESCRIPTION			
<p>The Communicable Disease Service (CDS) is seeking a Research Scientist 1/Epidemiologist & Wastewater Surveillance Coordinator to design and implement surveillance, research, and public health response activities associated with COVID-19 and other infectious disease pathogens; and provide back-up expertise for other respiratory virus surveillance, investigations, and outbreak response. This position will serve as the coordinator for the New Jersey Department of Health's National Wastewater Surveillance System (NWSS) program and will work closely with the Public Health and Environmental Laboratories, CDC, and local health departments to provide and analyze data on COVID-19, monkeypox, and other pathogens as an early detection surveillance approach. The Research Scientist 1 will identify and research metrics and develop tools to track the incidence and prevalence of pathogens in wastewater and to correlate data with other human surveillance indicators; and utilize wastewater surveillance data in conjunction with other surveillance tools to inform clinical testing and community mitigation strategies. This position will research and evaluate the effectiveness and use of wastewater surveillance data for community surveillance as well as for targeted populations, including nursing homes and institutes of higher education. Other job responsibilities include: providing consultation and technical assistance to CDS epidemiologists, local health departments, clinicians, and healthcare facilities on COVID-19 and other emerging pathogens and wastewater surveillance; serving as a liaison with state, federal, academic, and other partners; representing the Department of Health at conferences with outside stakeholders (e.g., CDC, other state agencies, and health departments outside New Jersey); preparing grant applications, budget requests, and grant-required reports and producing sound, accurate scientific articles and reports on investigations for publication in scientific journals and presentation at scientific meetings. Other responsibilities include overseeing the development of educational materials and informational webinars and using surveillance data to guide the development of public health recommendations (e.g., increased testing, outreach, and communication) to affected communities. This position will review and analyze scientific literature pertaining to current research developments and incorporate advances into research and investigations and serve as a liaison to local, state, and federal agencies, academic partners, and professional associations. This position will supervise and mentor lower levels of Research Scientists and other technical staff; and provide on-call services on evenings and weekends as required.</p> <p>The ideal candidate will have: academic credentials in epidemiology and/or environmental health, demonstrated knowledge and/or experience in infectious disease surveillance and epidemiology, strong data manipulation and analysis skills working with large databases, and the ability to manipulate data for analysis and visualization using SAS and Tableau. Knowledge of wastewater surveillance practices and lab-based approaches for detection of pathogens in wastewater is a plus as is experience using ArcGIS. Candidate must have demonstrated ability leading and supervising a team and communicating effectively orally and in writing with diverse audiences.</p>
