Provide guidance to State Monitors appointed to school districts and identify State Monitors to be assigned to fiscally distressed school districts. Assess the fiscal viability of at-risk districts and develop the recommended actions necessary to ensure the district meets all financial obligations and requirements. Assist identified districts with the comprehensive school district budgeting process in accordance with applicable statute, regulations, and industry best practices; and performs other related work as required.

Graduation from an accredited college or university with a Bachelor's degree in Accounting, Finance, Economics, Business Administration, Public Policy, or other related field.
