Description:

Under direction of the Assistant Commissioner of Finance and Business Services, supervises the development and implementation of all Office of School Bus Safety related initiatives; provides leadership, oversight, and supervision for staff within the Office of School Bus Safety, including preparing and signing official performance evaluations for subordinate staff; supervises the oversight of the school busing industry to ensure adherence to federal and state laws and regulations; strengthens interagency and statewide collaboration and partnerships to foster the implementation of strategies for school bus safety in New Jersey; proposes regulatory changes related to school bus safety; oversees coordination with other agencies, such as the New Jersey Motor Vehicle Commission and the Department of Law and Public Safety; oversees the District Report of Transported Resident Students (DRTRS) electronic data collection system; oversees the listing school bus contractors that have been debarred; prepares an annual report for the Commissioner of Education detailing the office's activities in the prior year; and performs other related work as required.

Requirements:

Education: Graduation from an accredited college or university with a Bachelor's degree.

Experience: Eight (8) years of experience in ensuring compliance with established statutory or regulatory programs, five (5) years of which shall have been in a supervisory capacity.

Preferred Education/Experience: A Master's degree in Business Administration, Public Policy, Transportation, Business Administration, Finance, or Project Management; three (3) years of experience in transportation; and experience preparing and providing testimony.

Open to the Following:

In accordance with the New Jersey First Act P.L. 2011 c.70, effective September 1, 2011, new public employees are required to obtain New Jersey residency within one (1) year of employment. Applicants must meet the requirements listed above.
