Opportunities currently exist in the unclassified service with the Department of Law and Public Safety, Division of Alcoholic Beverage Control, for applicants who meet the requirements specified below:

### **NUMBER OF POSITIONS AVAILABLE:** Two (2)

<u>DUTIES</u>: Under close supervision of the Chief of Investigations and a Supervising Investigator or other supervisory official in the Division of Alcoholic Beverage Control, performs regulatory audits and inspections of licensed premises; reviews records, files, financial statements, and other transactions to determine compliance with rules or regulations governing consumer protection laws; conducts civil and regulatory investigative activities or specialized investigations to detect alleged noncompliance with or violations of New Jersey State statutes, administrative codes, or Professional Rules of Conduct or consumer protection laws; engages in extensive interaction with various stakeholders including licensees, legal staff, outside counsel, municipalities, police, and both internal and external staff of the ABC, particularly regarding matters related to Title 33 statutes and regulations; performs and conducts investigations, including surveillance and undercover operations, to ensure adherence to regulatory standards; crafts detailed investigative reports, enforces Title 33 Statutes and the regulations promulgated thereunder; coordinates interviews; makes recommendations for both short term and long-range enforcement and investigation plans for licensees suspected of engaging in alleged illegal activities; reviews financial statements; performs other related duties as required. This position may, on occasion, require non-traditional work hours, on an as needed basis, including evenings and/or weekends or short deadlines for certain assignments during peak seasons, with or without advance notice and travel within the State.

#### **REQUIREMENTS**

**NOTE:** Applicants must meet one of the following or a combination of both experience and education. Thirty (30) semester hour credits are equal to one (1) year of relevant experience.

Five (5) years of professional experience in the conduct of civil or criminal investigations related to compliance, enforcement, detection, and surveillance activity, including the preparation of investigative reports.

## <u>OF</u>

Five (5) years of professional experience in the conduct of investigative administrative audits and/or regulatory examinations of records maintained by businesses and organizations.

# <u>OR</u>

Five (5) years of professional experience in the conduct of investigations for the government, the military, consumer protection programs, public advocacy organizations, or the public interest.

# <u>OR</u>

 $Possession \ of \ a \ bachelor's \ degree \ from \ an \ accredited \ college \ or \ university; \ and \ one \ (1) \ year \ of \ the \ above-mentioned \ professional \ experience.$ 

## <u>OR</u>

Possession of a juris doctorate or a master's degree in Criminal Justice, Public Administration, Business Administration, Law, or a related field.

**NOTE:** Completion of a supervised internship field placement of 300 hours in an undergraduate curriculum in Criminal Justice or a related degree program may be substituted for one (1) year of the non-supervisory experience.

**NOTE:** "Professional experience" refers to work that is analytical, evaluative, and interpretive; requires a range of basic knowledge of the profession's concepts and practices; and is performed with the authority to act and make accurate and informed decisions.

LICENSE: Appointee will be required to possess a driver's license valid in New Jersey.

**PREFERENCE:** Preference will be given to candidates with a knowledge of investigative report writing, finance and/or bookkeeping and/or accounting skills.

All offers of employment are conditional, subject to the applicant agreeing to, and then passing, a background check that may include fingerprinting.
