Scope of Eligibility: Open to applicants who meet the requirements below.

**Description:** Under the general supervision of a Supervising Biologist or other supervisory officer in the Department of Environmental Protection, assists with conducting, leading, and developing education programs at the Pequest Trout Hatchery and Natural Resource Education Center for school groups, the public and various user groups.

**Specific to the Position:** The appointee will lead environmental education programs, including freshwater fishing classes, hatchery tours, guided hikes, and various freshwater ecology programs, to school aged students, grades K – 12, and adults. Should be comfortable working outdoors in a variety of conditions, including sunny, hot, buggy, wet, and cold. The position requires having excellent communication skills and the ability to work well with volunteers organizing and running fishing education programs. Most education programs are from April to October.

Additional duties include maintaining equipment and supplies, assisting with covering the front desk, selling licenses, greeting the public and answering phones. Applicant should be available to work a varied schedule including weekdays, weekends, and occasional evenings.

**Preferred Skill Set:** College graduate with a Bachelor's degree in Environmental Science or related field. Freshwater fishing experience, knowledge of fishing equipment and tackle, teaching experience, and familiarity with New Jersey Fish & Wildlife regulations. Proficiency in Microsoft Office Suite (Excel, Publisher, Word).

## Requirements

**License:** Appointees will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform essential duties of the position.

**Residency:** All persons newly hired on or after September 1, 2011 have one year from the date of employment to establish, and then maintain principal residence in the State of New Jersey subject to the provisions of N.J.S.A. 52:14-7 (L.2011, Chapter 70), also known as the "New Jersey First Act".
