Under the direction of the Electrical Maintenance Supervisor, responsible for the inspection, repair and maintenance of electrical and/or electronic operating and control systems, equipment and fixtures, including instrumentation and heating and cooling systems. Some overtime and on-call may be required.

The successful applicant should be able to perform ALL of the following functions at a pace and level of performance consistent with the actual job performance requirements.

- Inspects and tests electrical equipment, signal, and communication and power circuits.
- Repairs, installs, replaces and tests electrical circuits, equipment and appliances
- Using hand tools and testing instruments.
- Isolates defects in wiring switches, motors, and other electrical equipment.
- Replaces faulty switches, sockets and other simple elements of electrical systems.
- Add, subtract, multiply and divide using whole numbers, common fractions and decimals.
Comply with all safety regulations
- Communicate effectively orally and in writing
- Mounts motors, transformers and lighting fixtures into position.
- Reads diagram specifications related to the task.
- Dismantles electrical machinery and replaces defective electrical or mechanical parts, such as gears, brushes and armatures.
- Reports all problems to the supervisor immediately.
- Complies with all agency policies, procedures and rules, written or otherwise, at all times.
- Performs all other duties as assigned and/or required.

QUALIFICATIONS:

High school diploma or GED, or Trade school certification or equivalent.

Possess and maintain a valid New Jersey electrical license-Preferred

Minimum of 5 years experience as an electrician in a commercial or industrial environment.

Must be able to read and follow schematic drawings, wiring diagrams and prints.

Must possess and maintain a valid New Jersey driver's license.
