Scope of Eligibility: Open to applicants who meet the requirements below.

Description: Under the direction of a supervisory official in a state department, institution, or agency, improves and maintains the physical condition of state property primarily by performing routine manual work; does other related duties as required.

Specific to the Position: Responsibilities include custodial services for patron health and safety, major/minor repairs, snow removal, basic painting, and carpentry. Also responsible for the care and maintenance of the infrastructures, grounds and out areas of the parks/forests, including but not limited to ground maintenance, janitorial services, and vehicle/equipment maintenance. State Park Service operations are seven (7) day year-round operations requiring weekends, holiday and after-hour coverage. Duties may include cleaning of restrooms, bathhouses, offices, and off-site facilities; maintaining campsites; maintenance of marina facilities; planning and making purchases for projects; general maintenance and upkeep of all buildings and grounds; mowing of lawn areas; snow/ice removal; clearing trees and trails; and upkeep of historic structures.

Requirements

EXPERIENCE:

One (1) year of experience in the maintenance of forests and/or parks or in general maintenance and repair work involving a variety of carpentry, painting, electrical, plumbing, masonry, and/or related tasks.

License: Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.

Appointee may be required to obtain a NJ Certified Pesticide Applicator's or Operator's permit in the required categories.

Appointees may be required to possess a valid Commercial Driver's License (CDL) and applicable endorsements for the class and type of vehicle being operated.

Residency: All persons newly hired on or after September 1, 2011 have one year from the date of employment to establish, and then maintain principal residence in the State of New Jersey subject to the provisions of N.J.S.A. 52:14-7 (L.2011, Chapter 70), also known as the "New Jersey First Act".

Authorization to Work: Selected candidates must be authorized to work in the United States per the Department of Homeland Security, United States Citizenship and Immigration Services regulations. **Note:** The State of New Jersey does not provide sponsorship for citizenship to the United States.

Veteran's Preference: To qualify for New Jersey Veteran's Preference/status, you must establish Veteran's Preference through the Department of Military and Veterans' Affairs.
