DUTIES: Under the direction of a Supervisory Official in the Department of Law and Public Safety, be thoroughly invested in the intelligence-led policing concept as well as demonstrating experience operating in an all-source intelligence environment. In addition, applicant(s) should be able to facilitate the Intelligence Cycle through a robust collection process, the ability to collate the data collected, perform analysis, and disseminate a final intelligence product to NJ stakeholders, applicant(s) should be versed in mobilization indicators and pathway to violence models to assist NJ Law Enforcement efforts in mitigating threat and crime actors from successfully planning and conducting terrorist activities in New Jersey and the region; applicant(s) must be able to simultaneously manipulate multiple data sets to derive inputs for intelligence and investigative packages in an ever-changing and challenging environment with the ability to problem solve against multiple competing priorities and assist the NJ ROIC in identifying intelligence gaps; determine the validity, reliability, and credibility of collected information, understand and comply with Title 28 CFR Part 23, NJ Attorney General Guidelines for Handling Intelligence, federal and State Laws, and applicable New Jersey State Police Standard Operating Procedures pertaining to intelligence production, storage, and dissemination; prepare and confidently deliver concise briefings to management at all levels, obtain and maintain situational awareness and subject matter expertise in intelligence tradecraft; and perform other related duties as required.

REQUIREMENTS

NOTE: Applicants must meet one of the following or a combination of both experience and education. Thirty (30) semester hour credits are equal to one (1) year of relevant experience.

Eight (8) years of professional experience in the conduct of civil or criminal investigations related to compliance, enforcement, detection, and surveillance activity, including the preparation of investigative reports.

Eight (8) years of professional experience in the conduct of investigative administrative audits and/or regulatory examinations of records maintained by businesses and organizations.

OR

Eight (8) years of professional experience in the conduct of investigations for the government, the military, consumer protection programs, public advocacy organizations, or the public interest.

OR

Possession of a bachelor's degree from an accredited college or university; and four (4) years of the above-mentioned professional experience.

OR

Possession of a juris doctorate or a master's degree in Criminal Justice, Public Administration, Business Administration, Law, or a related field; and three (3) years of the above-mentioned professional experience.

NOTE: Completion of a supervised internship field placement of 300 hours in an undergraduate curriculum in Criminal Justice or a related degree program may be substituted for one (1) year of the non-supervisory experience.

NOTE: "Professional experience" refers to work that is creative, analytical, evaluative, and interpretive; requires a range and depth of specialized knowledge of the profession's principles, concepts, theories, and practices; and is performed with the authority to act according to one's own judgment and make accurate and informed decisions.

<u>LICENSE:</u> Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is required to perform the essential duties of the position.
