NUMBER OF POSITIONS AVAILABLE: One (1)

DUTIES: Under direction of a Chief Investigator or other supervisory official in the Department of Law and Public Safety, plans, organize and supervise investigative teams or specialized investigators conducting complex data security and data privacy investigations, including conducting in depth regulatory and administrative audits and inspections of licensed premises; and reviewing records, files, financial statements, and other transactions to determine compliance with the New Jersey Consumer Fraud Act, and other laws concerning cyber security, including, but not limited to, the New Jersey Computer Related Offenses Act (CROA); the federal Children's Online Privacy Protection Act of 1998 and regulations (COPPA); the New Jersey Identity Theft Protection Act; the Health Information Technology for Economic and Clinical Health Act (HITECH), and the Health Insurance Portability and Accountability Act of 1996 (HIPAA).

REQUIREMENTS

NOTE: Applicants must meet one of the following or a combination of both experience and education. Thirty (30) semester hour credits are equal to one (1) year of relevant experience.

Nine (9) years of professional experience in the conduct of civil or criminal investigations related to compliance, enforcement, detection, and surveillance activity, including the preparation of investigative reports, one (1) year of which shall have been in a team leader, or lead investigator capacity. **OR** Nine (9) years of professional experience in the conduct of investigative administrative audits and/or regulatory examinations of records maintained by businesses and organizations, one (1) year of which shall have been in a team leader, or lead investigator capacity. **OR** Nine (9) years of professional experience in the conduct of investigations for the government, the military, consumer protection programs, public advocacy organizations, or the public interest, one (1) year of which shall have been in a team leader, or lead investigator capacity.

OR

Possession of a bachelor's degree from an accredited college or university; and five (5) years of the above-mentioned professional experience, one (1) year of which shall have been in a team leader, or lead investigator capacity.

OR

Possession of a juris doctorate or a master's degree in Criminal Justice, Public Administration, Business Administration, Law, or a related field; and four (4) years of the above-mentioned professional experience, one (1) year of which shall have been in a team leader, or lead investigator capacity.

NOTE: Completion of a supervised internship field placement of 300 hours in an undergraduate curriculum in Criminal Justice or a related degree program may be substituted for one (1) year of the non-supervisory experience.

NOTE: "Professional experience" refers to work that is creative, analytical, evaluative, and interpretive; requires a range and depth of specialized knowledge of the profession's principles, concepts, theories, and practices; and is performed with the authority to act according to one's own judgment and make accurate and informed decisions.

PREFERENCE: Preference will be given to applicants with a Master's degree in Computer Science; or relevant industry experience/knowledge of data analytics and management; or Certified Information Privacy Technologist (CIPT).

LICENSE: Appointees will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.
