Scope of Eligibility: Open to applicants who meet the requirements below.

Description: Under the close supervision of a supervisory official in an Environmental Services program, in a state department, institution, or agency, learns to conduct routine surveys, studies, inspections, and/or investigations relating to the improvement and/or monitoring of environmental conditions, and/or the enforcement of environmental laws/regulations; does other related duties as required.

Specific to the Position: Job duties include analyzing data, conducting research, and communicating findings on water quality to inform decision-making. Projects may involve contributing to the development of New Jersey Integrated Water Quality Assessment Reports (IR), Total Maximum Daily Load (TMDL) calculations and reports, water quality restoration or protection plans, and Surface or Ground Water Quality Standards. The appointee may provide general program support, such as organizing water quality monitoring data, researching water quality topics, and other related tasks.

The ideal candidate will possess strong analytical, technical writing, and presentation skills, and have a basic understanding of environmental science, water quality, and land use planning,

Preferred Skill Set: Experience using ArcGIS to assess monitoring data and present organized analyses and results. Familiarity with creating StoryMaps, particularly for use in the Integrated Report (IR), Surface Water Quality Standards (SWQS), and Watershed Ambassadors data visualizations. Ability to update website components using WordPress, including publishing graphs, charts, and written content for web-based reports. Proficient in R or Python computer programming skills to organize large datasets. Proficient in Microsoft Word, Excel, and PowerPoint. Skilled in data analysis and data management.

Requirements

Graduation from an accredited college or university with a Bachelor's degree in one of the Physical Sciences, Environmental Sciences/Studies, Chemical Sciences, or Biological Sciences; or in Environmental Planning, Environmental Policy, or Physical Geography; or, in Civil Engineering, Sanitary Engineering, Chemical Engineering, Environmental Engineering, Mechanical Engineering, Agricultural Engineering, Mining Engineering, Industrial Engineering, or Bio-resource Engineering.
