GENERAL DESCRIPTION

Under the direction of a supervisory officer in a State department, institution, or agency, as a trainee and productive worker, receives on-the-job training in government personnel practices and procedures and their application and does work which will provide practical personnel experience; does related work. The trainee may perform payroll audits, certify payrolls, process pension memberships, process employee separations, prepare and run reports in Business Objects, assist in New Hire Orientations, train in the process of Certifications, recruitment, vacancy announcements, reinstatements, payroll changes, conversions, process leaves and worker's compensation and learn how to interpret rules, regulations and hospital policy.

ADVANCEMENT: Appointees who successfully complete the 12-month training period will be eligible for advancement to one of the following titles under Civil Service Commission procedures: Personnel Assistant 4, Personnel Assistant 4 Employee Relations, and Human Resource Consultant 1.

The inability of an employee in this title to attain a level of performance warranting advancement to a title listed above shall be considered cause for separation.

REQUIREMENTS (EDUCATION / EXPERIENCE / LICENSES)

EDUCATION: Graduation from an accredited college or university with a Bachelor's degree.

LICENSE: Appointees will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform essential duties of the position.
