GENERAL DESCRIPTION					
The Special Treatment Unit is a 500-bed secured forensic facility located in Avenel, NJ. The STU population consists primarily of adult males. Our inpatient units are designed to treat adults who have been civilly committed under the NJ Sexually Violent Predator's Act. The cognitive level varies with IQs ranging from 48 to 137. A small portion of our population have traditional Axis I psychiatric diagnoses, but many suffer from personality disorders. In support of Education services, the Special Treatment Unit is in need of certified Teachers to teach Adult Basic skills, K-8, and support GED/TASC learning. The best individual for these needs would have several years of experience as a certified teacher, flexibility, experience with various education levels and confidence within skill set to support appropriate boundaries during instruction within a secure environment. NOTE: This position is covered by the Centers for Medicare and Medicaid Services (CMS) Rule and Executive Order 283, requiring all employees to be fully vaccinated. To comply with that requirement, employees must provide proof of vaccination status. Please do not submit proof of vaccination at this time; instructions will be provided if an offer of employment results from this Vacancy Announcement.					
REQUIREMENTS (EDUCATION / EXPERIENCE / LICENSES)					
Possession of a valid NJ Standard Teacher's Certificate or Permanent Endorsement, issued by the Board of Examiners of the New Jersey Department of Education, authorizing instruction in subjects areas appropriate to the teaching assignment, as determined by the head of a particular school or district.					
NOTE: Teacher 3 is utilized to teach differing student populations and different content areas; therefore, the specific teaching certificate may vary.					
EXPERIENCE: Thirty-six (36) months of full-time, properly certified teaching experience in an approved school, earned after the receipt of the New Jersey Standard Teacher's Certificate.					
SPECIAL NOTE: Ability to physically lift, move, and position students.					
LICENSE: Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.
