Opportunities currently exist in the unclassified service with the Department of Law and Public Safety, Division of Criminal Justice, for applicants who meet the requirements specified below:

**TITLE:** Deputy Attorney General 4 **OR** Deputy Attorney General 3

**SALARY:** \$87,578.62 to \$124,980.46 \$100,682.82 to \$143,971.92

**NUMBER OF POSITIONS AVAILABLE:** Five (5) – Unit and Location preference required.

**DUTIES:** Under the direction of a Bureau Chief, Assistant Bureau Chief, or other supervisory official in the Office of the Insurance Fraud Prosecutor (OIFP), Division of Criminal Justice, Department of Law and Public Safety, investigates and prosecutes violations of New Jersey criminal laws, specifically private insurance fraud (e.g., property or medical), auto theft and related insurance fraud, Medicaid fraud, or the abuse, neglect or financial exploitation of the elderly. The Deputy Attorney General will interpret and enforce laws and regulations; conduct work concerned with the detection and prosecution of criminal activities; provide legal guidance to law enforcement officers regarding same; draft memoranda of law; and handle all aspects of case litigation, including, but not limited to, case assessment, research, discovery coordination, grand jury presentations, court appearances, pre-trial preparation, court filings (motions, briefs, sentencing memoranda), attorney correspondence and case management, and trial practice. Serves on various task forces and working groups for OIFP; works closely with supervisory and executive staff to cultivate, improve, and maintain strong working relationships with local, state, and federal law enforcement partners; works on special projects and initiatives; and performs other related work as needed. This position may also require non-traditional work hours, on an as needed basis, including evenings and weekends on short deadlines for certain assignments, with or without advanced notice.

### REQUIREMENTS

**EDUCATION:** Graduation from an accredited law school with a Juris Doctor. Admission to practice as an Attorney at Law in the State of New Jersey is required.

#### EXPERIENCE:

DEPUTY ATTORNEY GENERAL 4: Two (2) years of experience as a practicing attorney.

DEPUTY ATTORNEY GENERAL 3: Three (3) years of experience as a practicing attorney.

**LICENSE:** Appointee will be required to possess a driver's license valid in New Jersey.

**SPECIAL NOTE:** Current Department employees appointed to a Deputy Attorney General 4 or 3 title must be willing to accept a lateral transfer, if selected.

**SALARY NOTE:** For newly hired individuals, the starting salary and title will be determined by the Department commensurate with experience. Salary offers and titles are non-negotiable and will fall within the range posted.

**PREFERENCE:** Preference will be given to candidates who possess at least three (3) years of criminal litigation experience, as well as demonstrated experience investigating and prosecuting criminal offenses in the State of New Jersey, trial experience, and excellent written and oral advocacy skills.

All offers of employment are conditional subject to the applicant agreeing to and then passing a background check that may include fingerprinting.
