DUTIES: Under the general supervision of a Research Data Manager or other supervisory official in the Department of Law and Public Safety (DL&PS) Office of Justice Data (OJD), Law Enforcement Professional Standards (OLEPS) or Juvenile Justice Commission (JJC), is responsible for the planning of operations, development of staffing requirements, organizing and directing the work of a group of employees; responsible for the leadership of specialized statistical research or data analytics; supervises staff and work activities; prepares and signs official performance evaluations for subordinate staff; does other related duties as required. REQUIREMENTS

NOTE: Applicants must meet one of the following or a combination of both experience and education. Thirty (30) semester hour credits are equal to one (1) year of relevant experience.

Nine (9) years of professional experience in collecting, analyzing, reporting, and disseminating large volumes of data using statistical techniques to identify trends or patterns in complex data for research projects; including or supplemented by 18 credits in social sciences, criminal justice, statistics, or a closely related field.

OR

Possession of a bachelor's degree from an accredited college or university, including or supplemented by 18 credits in social sciences, criminal justice, statistics, or a closely related field; and five (5) years of the above-mentioned professional experience.

OR

Possession of a master's degree in social sciences, criminal justice, statistics, or a closely related field; and four (4) years of the above-mentioned professional experience.

OR

Possession of a Ph.D. in social sciences, criminal justice, statistics, or a closely related field; and three (3) years of the above-mentioned professional experience.

NOTE: "Professional experience" refers to work that is creative, analytical, evaluative, and interpretive; requires a range and depth of specialized knowledge of the profession's principles, concepts, theories, and practices; and is performed with the authority to act according to one's own judgment and make accurate and informed decisions.

LICENSE: Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform essential duties of the position.

PREFERENCE: Preferences for persons with expertise in data coding, restructuring, visualization, process & workflow development in addition to R, Python, SQL, Tableau, SPSS, SAS, Stata, Power BI, or VBA.

RESUME NOTE: Eligibility determinations for experience and education will be based upon the resume and unofficial transcripts submitted at the time of application. Applicants who possess foreign degrees (degrees earned outside of the U.S.) are required to provide a CSC approved evaluation indicating the U.S. equivalency, with a course-by-course breakdown, prior to the closing date (see [CSC foreign degree information](#)). Failure to do so may result in disqualification of your education towards eligibility.
