<b>DEFINITION</b>	<p>Under close supervision of a supervisory official or other designated official in a state department, institution, or agency, assists with respect to regulatory matters, formal and informal, both legislative and quasi-judicial in nature, including matters related directly to administrative procedure and policy matters considered by the agency; does related work as required.</p> <p>This position will serve in the Office of Policy and Legal Affairs and be responsible for legal, legislative and regulatory analysis and writings. This Office is responsible for issuing and maintaining policy manuals and forms, promulgating regulations, issuing information transmittals for the various Division programs and overseeing the Fair Hearing process for public assistance appeals. This Office also acts as a liaison between DFD and the Office of the Attorney General in receiving, formulating and transmitting requests for legal advice/representation on behalf of DFD and preparing reports and recommendations on the impact of proposed or existing legislation.</p>

<b>EDUCATION</b>	Graduation from an accredited law school with a Juris Doctor (J.D.) Degree.				
<b>EXPERIENCE</b>	One (1) year of experience in conducting legal research, analyzing and evaluating legal documents, rules, regulations, and/or legislation, or the review and analysis of regulatory matters in a government agency; or one (1) year of experience as an attorney.

<b>IMPORTANT NOTICE</b>					
<b>RESIDENCY</b>	Effective 9/1/11, NJ PL 70 (NJ First Act), requires all State employees to reside in New Jersey, unless exempted under the law, or current employees who live out-of-state and do not have a break-in service of more than 7 calendar days, as they are "grandfathered." New employees or current employees who were not grandfathered and who live out-of-state have one year after the date of employment to relocate their residence to New Jersey or request an exemption. Current employees who reside in NJ must retain NJ residency, unless he/she obtains an exemption. Employees who fail to meet the residency requirements or obtain an exemption will be removed from employment.
