GENERAL DESCRIPTION			
<p>Under direction of a supervisory official this position is responsible for evaluating the quality of the data being sent through electronic data exchange to ensure immunization records are accurate and complete. Performs comprehensive quality review of New Jersey Immunization Information System (NJIIIS) interface submissions to ensure data quality (completeness, accuracy, and timeliness). Provides technical and program support to Immunization Information System (IIS) partners that are onboarding to unit directional and bi-directional web-based immunization information exchange. Analyzes application issues and troubleshoots problems. Assists in the development of the COVID-19 provider enrollment module within NJIIS. Promotes and supports efforts to implement interfaces with NJIIS using HL7 bi-directional messaging to reduce barriers in collecting COVID-19 vaccine administration data, as directed. Plans, conducts, and develops analytical studies of existing operations/routines to determine feasibility for data processing and makes recommendations. Provides system support to users. Ensures data collection via interface is in accordance with HL7 specifications.</p>
