DEFINITION	Under the close supervision of a Program Specialist 3, Program Specialist 4, or other supervisory officer in a State department or agency, as a trainee and productive worker, receives on-the-job training while assisting in the professional, administrative, and analytical work to promote the planning, operation, implementation, monitoring and/or evaluation of human or social service programs, programs serving the socio-economic needs of specific clients populations, or regulatory programs designed to ensure public safety, health and welfare, or protection of the environment; completes assignments which provide practical Program Specialist experience; does other related work.  The full time specialist will be completing Hard of Hearing Specialist tasks. The employee will work with equipment and hearing aid program applications, demonstrate assistive devices, and conduct and coordinate workshops and conferences. In addition, the full time specialist will consult with clients, families, and agencies with regard to devices for effective communication, outreach to inform consumers of our services and programs, and prepare comprehensive statistical and other reports containing findings, conclusions and recommendations. The incumbent will prepare educational presentations on assistive listening devices, including an overview of the program and attend organizational meetings, councils, and conferences. RESIDENCY	Effective 9/1/11, NJ PL 70 (NJ First Act), requires all State employees to reside in New Jersey, unless exempted under the law, or current employees who live out-of-state and do not have a break-in service of more than 7 calendar days, as they are "grandfathered." New employees or current employees who were not grandfathered and who live out-of-state have one year after th date of employment to relocate their residence to New Jersey or request an exemption. Current employees who reside in NJ must retain NJ residency, unless he/she obtains an exemption. Employees who fail to meet the residency requirements or obtain an exemption will be removed from employment.
