## Job Description

The Department of Labor and Workforce Development (DOL) provides many benefits to employees to acknowledge and value their contribution. The DOL is in a telework pilot and permits two days of telework. Statewide benefits include health insurance, pension, Flexible Spending Accounts (FSA)/Health Savings Accounts (HSA), life insurance, deferred compensation and more. DOL also provides tuition reimbursement (after nine months of employment), Alternate Workweek Program (determined by division), and employee training.

#### About the Role:

Under close supervision, as a trainee and productive worker in a state department or agency, receives on-the-job training in determining that the goals and objectives of a department's affirmative action program and/or contract compliance program are being met, in a department's dealings with the public and outside agencies, and/or in its own internal operation; does other related duties as required.

- Studies and reviews the internal and external operations of a specific organizational unit; provides recommendations for improvement to the Affirmative Action Officer with respect to the unit's equal employment opportunity and affirmative action activities.
- Under direction, meets with supervisory officers and other personnel to determine areas where improvement is necessary.
- Receives training from the department's Equal Opportunity Officer to ensure policies and actions pursued in the assigned unit are in accord with those of the department.
- Meets with representatives of the public and outside agencies to explain the agency's affirmative action commitment, and
  to acquire firsthand knowledge of program's impact on persons and agencies that share an interest in the agency's
  activities.
- Acts as liaison with agency staff involved in submitting personnel actions; acts as liaison with Personnel Assistants in order to investigate the technical aspects of any complaints received.
- May assist in analyzing and evaluating possible labor compliance violations and complaints.
- Prepares correspondence.
- Prepares reports on all activities containing findings, conclusions and recommendations.
- Periodically meets with agency employees to provide information on current affirmative action activities.
- Will be required to learn to utilize various types of electronic and/or manual recording and information systems used by the agency, office, or related units.

Four (4) years of professional experience involving the implementation of equal employment opportunity, affirmative action and/or civil rights.

Possession of a bachelor's degree from an accredited college or university.

**NOTE:** "Professional experience" refers to work that is analytical, evaluative, and interpretive; requires a range of basic knowledge of the profession's concepts and practices; and is performed with the authority to act and make accurate and informed decisions.

**ADVANCEMENT:** Appointees who successfully complete the 12-month training period will be eligible for advancement to one of the following titles under Department of Personnel procedures: **Affirmative Action Specialist 3** (**Title Code**:65962) in accordance with Civil Service Commission procedures. The inability of an employee in a trainee title to attain a level of performance warranting advancement shall be considered cause for separation.

**RESUME NOTE:** Eligibility determinations will be based only upon information presented on the resume along with other supporting documents. Applicants who possess a degree from a college or university outside the United States must provide an evaluation of the transcripts from a recognized evaluation service at the time of submission. Failure to do so may result in your ineligibility.

**LICENSE:** Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.

#### PERSONAL RELATIONSHIPS DISCLOSURE STATEMENT

In accordance with the Uniform Ethics Code adopted by the NJ State Ethics Commission and the State Policy Prohibiting Discrimination in the Workplace, the New Jersey Department of Labor and Workforce Development (NJ DOL) requires the disclosure of all relatives, consensual personal relationships, and cohabitants. No NJ DOL employee may supervise or exercise any authority with regard to personnel actions involving their relative, anyone with whom there is a consensual personal relationship, or anyone with whom they cohabit.

**Relative** means an individual's spouse/domestic partner/civil union partner<sup>1</sup> or the individual or spouse's/domestic partner's/civil union partner's parent, child, brother, sister, aunt, uncle, niece, nephew, cousin, grandparent, grandchild, son-in-law, daughter-in-law, stepparent, stepchild, stepbrother, stepsister, half-brother or half-sister, whether the relative is related to the individual or the individual's spouse/domestic partner/civil union partner by blood, marriage or adoption.

Consensual personal relationship means marriage, engagement, dating or other ongoing romantic or sexual relationships.

Cohabitant means non-related persons who share a household under circumstances where there is financial interdependence.

The New Jersey Department of Labor and Workforce Development requires the disclosure of all relatives and consensual personal relationships to be promptly reported directly to the Division of Human Capital Strategies (HCS), Director's Office. Confidentiality shall be maintained to the extent possible and practicable. This information may be shared with NJ DOL's Equal Employment Opportunity Office and/or the NJ DOL Ethics Office as deemed necessary. Upon receiving notice of the relationship, HCS may address any situation as necessary in consultation with the EEO Office and/or the Ethics Officer. This may include, but is not limited to, the changing of reporting relationships or transferring any of the employees involved. Failure to provide notification to HCS may result in discipline up to and including termination and the denial of legal representation and indemnification by the State in the event that a lawsuit is filed having a connection with a personal relationship. Employees are under a continuing obligation to promptly report personal relationships that develop during the course of their employment.
