**<u>DEFINITION:</u>** Under the direction of a supervisory officer in a State department, institution, or agency, as a trainee and productive worker, receives on-the-job training in government personnel practices and procedures and their application and does work which will provide practical personnel experience; does related work.

**EDUCATION:** Graduation from an accredited college or university with a Bachelor's degree.

**ADVANCEMENT:** Appointees who successfully complete the 12-month training period will be eligible for advancement to the title of Personnel Assistant 4.

**SPECIAL NOTE:** Candidates should have knowledge and/ or ability to utilize Microsoft Office Excel and Visio. Among various duties, this position will perform some filing duties and assist with the on-boarding process. Candidates having a Bachelor's degree with a major in Human Resources or a related field will be given preference.

**RESIDENCY LAW:** Pursuant to N.J.S.A. 52:14-7 (L. 2011, Chapter 70), also known as the "New Jersey First Act," which became effective September 1, 2011, all persons newly hired by the Executive Branch on or after that date shall have one year from the date of employment to establish, and then maintain, principal residence in the State of New Jersey. New Jersey state employees hired prior to September 1, 2011 who transfer from within the Executive Branch or from another State of New Jersey appointing authority without a break in service greater than seven days but who reside outside the State of New Jersey are not required to change their principal residence to New Jersey in order to comply with the Act.
