#### **REQUIREMENTS**

**EXPERIENCE:** Four (4) years of experience having responsibility for implementing an inventory control system, including processing, storing, shipping, receiving and documentation, in a public or private agency.

<u>LICENSE</u>: Appointees will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.

**SPECIAL NOTE:** Special Services positions are filled on a part-time, temporary basis during normal business hours. Candidates appointed to a Special Services title will be limited to 944 work hours in a fiscal year.
