## **NUMBER OF POSITIONS AVAILABLE:** Two (2)

<u>DUTIES:</u> Under the direction of the Bureau Chief, Deputy Bureau Chief, or other supervisory official in the Office of Public Integrity and Accountability, Department of Law & Public Safety (LPS) investigates and prosecutes violations of New Jersey criminal laws, specifically related to public corruption offenses and criminal activities that violate the public trust. This Deputy Attorney General will provide legal advice and representation of the State on matters of a complex nature; interpret and enforce laws and regulations; participate in legal and related activities involving federal and local jurisdictions and other State entities; draft memoranda of law; handle all aspects of case litigation, including but not limited to case assessment, legal research, discovery coordination, grand jury presentations, court filings, attorney correspondence, court appearances, motion practice, pretrial preparation, case management, and trial; serves on various task forces and working groups for the Office or LPS; works on special projects and initiatives; and performs other related work as needed. This position may also require non-traditional work hours, including evenings and weekends on short deadlines for certain assignments, with or without advance notice, and may require travel to perform the aforementioned responsibilities.

### **REQUIREMENTS**

**EDUCATION:** Graduation from an accredited law school with a Juris Doctor. Admission to practice as an Attorney at Law in the State of New Jersey is required.

**EXPERIENCE:** Three (3) years of experience as a practicing attorney.

**LICENSE:** Appointee will be required to possess a driver's license valid in New Jersey.

**PREFERENCE:** Preference will be given to candidates with prior prosecution experience; trial experience; a demonstrated ability to multi-task and work effectively with a broad cross-section of stakeholders; and excellent written and oral advocacy skills.

**SAME APPLICANTS:** If you are applying under the NJ CSC "SAME" program, your Schedule A or B letter must be submitted along with your resume and any other required supporting documents indicated on the announcement by the closing date indicated below. Failure to do so may result in disqualification of your education towards eligibility.

All offers of employment are conditional subject to the applicant agreeing to and then passing a background check that may include fingerprinting.
